## **MAGNOLIA MUSIC SHOWCASE RULES**

- 30 Entries maximum
- Entries must be delivered to KLBC / The Buzz via email or delivered to the station. Must be video, MP3 or wav file
  - Email to [showcase@klbcfm.com](mailto:showcase@klbcfm.com)
  - Drop off @ 1418 N. 1<sup>st</sup>, Durant, OK
- Cut Committee will choose the top 12 submissions.
- Top 12 will perform on June 4<sup>th</sup> at the Magnolia Festival. Order will be chosen by blind draw. Blind Draw done Thursday night and available via Zoom.
- June 4<sup>th</sup> - All contestants will use a common backline and play 2 songs. Max time of 10 minutes. Solo artists can use backing tracks. Backing tracks must be digital and delivered to KLBC by June 1<sup>st</sup> via email or on a thumb drive.
- Performances will be judged by a panel to pick the top 5.
- Top 5 will perform on June 5<sup>th</sup>. Each will be given a 20-minute set. Order of performance will be done by a blind draw. Draw will be done at the time the 5 finalists are announced.
- Live performances will be judged on the following:
  - Musicianship
  - Vocal
  - Stage Presence
  - Material (original or cover)
  - Crowd Response
- Judges decision(s) are final
- Winning act understands they are responsible for any tax liability incurred from winnings.
